DUTIES:

You will serve as a Senior Geotechnical Engineer for the Pittsburgh Army Corps of Engineers District.

You will:

- Direct and review the work of intermittently assigned technicians, lower graded engineers, and/or AEs in the development of products for dam safety projects;
 - Serve as project geotechnical engineer for dam safety modification work;
 - Develop complex geotechnical engineering designs for dam safety modification;
 - Develop subsurface exploration and laboratory programs to determine soil parameters to support stability analysis, etc.;
 - Perform slope stability and underseepage analysis, relief well and seepage barrier design, seismic design, risk and reliability analysis, and geotechnical modeling;
 - Provide geotechnical engineering input for dam safety risk assessments, potential failure modes analyses, etc;
 - Produce or contribute to dam safety modification reports, design documentation reports, and construction contract plans and specifications;
 - Provide internal review or similar peer review;
 - Develop AE design contracts and construction plans and specifications; and
 - Oversee and ensure success of all facets of contracted design and service contract work.

QUALIFICATIONS REQUIRED:

In order to qualify, you must meet the education and/or experience requirements described below.

Your resume must clearly describe your relevant experience; if qualifying based on education, your

Experience required: To qualify based on your work experience, your resume must describe at least one year of experience which prepared you to do the work in this job. Specialized experience is defined as: Experience in geotechnical engineering design to address dam safety deficiencies associated with large infrastructure and dam safety risk assessment. This definition of specialized experience is typical of work performed at the next lower grade/level position in the federal service (GS-11).

Selective Placement Factor: This position requires a current registration as a Professional Engineer (PE). A copy of your current PE License's must be submitted with your application package.

You will be evaluated on the basis of your level of competency (knowledge, skills, abilities) in the following areas:

- Geotechnical Engineering
- Oral Communication
- Contract Administration
- Dam Safety
- Project Management
- Geotechnical Design

Education required: This position has a minimum education requirement. In order to qualify for this position, you must meet one of the education requirements below in addition to the specialized experience statements described above.

- A bachelor's degree or above in professional engineering from a college or university accredited by the Accreditation Board for Engineering and Technology (ABET). NOTE: THIS DOES NOT INCLUDE ENGINEERING TECHNOLOGY;
- A bachelor's degree or above in professional engineering. The curriculum included differential and integral calculus and courses (more advanced than first- year physics and chemistry) in five of the following seven areas of engineering science or physics: (a) statistics, dynamics; (b) strength of materials (stress/strain relationships); (c) fluid mechanics, hydraulics; (d) thermodynamics; (e) electrical fields and circuits +ADs (f) nature and properties of materials (relating particle and aggregate structure to properties); and (g) any other comparable area of fundamental engineering science of physics, such as optics, heat transfer, soil mechanics, or electronics;
- Current registration as a professional engineer by a state in the United States, the District of Columbia, Guam, or Puerto Rico, in addition to college-level education, training, and/or technical expertise that furnished (1) a thorough knowledge of the physical and mathematical sciences underlying professional engineering, and (2) a good understanding, both theoretical and practical, of

the engineering sciences and techniques and their applications to one of the branches of engineering;

- Successful completion of the Engineer in Training examination, or the written test required for professional registration, administered by the Boards of Engineering Examiners in the various States, the District of Columbia, Guam, and Puerto Rico in addition to completion of all the requirements for either (a) a bachelor's degree in engineering technology (BET) from an accredited college or university that included 60 semester hours of courses in the physical, mathematical, and engineering sciences, or (b) a BET from a program accredited by the ABET+ADs;
- A combination of at least 4 years of college-level education, training, and/or technical expertise that included successful completion of at least 60 semester hours of courses in the physical, mathematical, and engineering sciences, including the courses listed in paragraph B above. The courses are fully acceptable toward meeting the requirements of a professional engineering curriculum; OR
- A bachelor's degree or higher-level degree in engineering technology or in an appropriate professional field (for example, physics, chemistry, architecture, computer science, mathematics, hydrology, or geology) and at least one (1) full year of professional engineering experience that was acquired under a professional training program or under professional engineering supervision and guidance.

Only degrees from an accredited college or university recognized by the Department of Education are acceptable to meet positive education requirements or to substitute education for experience.
