DUTIES:

As a Senior Construction Control Representative you will:

- Provide expertise and guidance concerning safety and quality assurance
 - Monitors the provisions of the contractor safety program for compliance
 - Inspect job site for compliance with applicable regulations
 - Review all contractor safety plans
 - Interprets plans and contract requirements
 - Maintains continuing quality assurance operations
 - Analyze problems and reviews and interprets the requirement of plans and specifications
 - Monitors the layout of work and inspection of all work in progress

QUALIFICATIONS REQUIRED:

In order to qualify, you must meet the education and/or experience requirements described below. Your resume must clearly describe your relevant experience; if qualifying based on education, your transcripts will be required as part of your application. Experience required:

Experience refers to paid and unpaid experience, including volunteer work done through National Service programs (e.g., Peace Corps, AmeriCorps) and other organizations (e.g., professional; philanthropic; religious; spiritual; community; student; social). You will receive credit for all qualifying experience, including volunteer experience.

To qualify based on your experience, your resume must describe at least one year of experience which prepared you to do the work in this job.

Specialized experience is defined as: knowledge of safety standards and environmental regulations related to construction safety and quality assurance; experience with assisting in project oversight and construction services for the construction, repair, and alteration of dams, levees or other facilities. Such experience must have included the application of construction management, inspection of construction; application of construction techniques; and experience interpreting engineering and construction contract plans and specifications.

This definition of specialized experience is typical of work performed at the next lower grade/level position in the federal service (GS-11).

You will be evaluated on the basis of your level of competency (knowledge, skills, abilities) in the following areas:

- Safety Enforcement
- Knowledge of Construction Management
- Construction Contract Quality Assurance

For this position you cannot substitute education for experience. You must qualify based on Specialized Experience alone.

- One year trial/probationary period may be required.

HOW YOU WILL BE EVALUATED:

Basis for Rating: Qualified candidates will be assigned to one of three quality categories: Best Qualified, Highly Qualified and Qualified. Veteran preference eligibles are listed ahead of non-preference eligibles within each quality category.

- Best Qualified. Candidates in this category possess exceptional skills and experience to exceed well above the minimum requirements for the announced position.
- Highly Qualified. Candidates in this category possess good skills and experience above the minimum requirements for the announced position.
- Qualified. Candidates in this category meet the minimum experience requirements for the announced position.

Your resume:

- Your resume may be submitted in any format.
- If you submit more than one copy of your resume, only the most recent version will be reviewed. The latest timestamp will be used to determine which version of your resume is "most recent." It is your responsibility to check the status and timestamp of all documents you submit as part of your application.
- If your resume includes a photograph or other inappropriate material or content, it will not be used to make eligibility and qualification determinations and you may not be considered for this vacancy.
- For qualifications determinations your resume must contain hours worked per week and the dates of employment (i.e., HRS per week and month/year to month/year or month/year to present). If your resume does not contain this information, your application will be marked as incomplete and you will not receive consideration for this position.
