### **About the Position:**

This position is located in the Engineering and Construction Division, Structural Design Section, Navigation Design Branch, U.S. Army Corps of Engineers, Pittsburgh District, Pittsburgh, PA.

This vacancy is being announced at the GS-11 and GS-12 grade levels. Management may select at either grade level. If selected at the GS-11 level you may be noncompetitively promoted to target level GS-12.

**DUTIES:**

Works under the supervision of the Chief, Structural Design Section, receiving assignments in terms of overall objectives and requirements. Plans and carries out assignments independently, adapting or modifying standard guides and criteria as needed. Advice and assistance are available on crucial problems and issues or matters requiring deviation from standard policy. Completed work is checked for timely completion, technical accuracy, conformance to policies and procedures and soundness of professional engineering judgment. Overall performance is evaluated in terms of performance appraisal standards established by the supervisor.

Applicants will be responsible for duties such as (but not limited to):

Performing structural engineering assignments consisting of complete segments of work for large, complex projects using established design criteria and directives. As part of design or evaluation of various structures, prepares design narratives, structural design calculations, and drawings using AutoCAD software for civil works construction projects.

- Conduct analysis & designs. Prepare construction contract documents for various structural features for difficult or complex civil engineering projects for river navigation systems, local flood protection projects, and flood control reservoir projects.
- Determining requirements for technical aspects of project specifications, and prepares amendments and engineering revisions for the above projects.
- Coordinating structural aspects of projects with architects and other engineers responsible for related specialized phases of the projects to arrive at mutually acceptable designs and solutions to problems.
- Supplies standard engineering methods and techniques in the performance of preliminary and final design including stress and stability analysis, estimates, and typical sections for steel or concrete features.

## QUALIFICATIONS REQUIRED:

In order to qualify, you must meet the education and/or experience requirements described below. Your resume must clearly describe your relevant experience; if qualifying based on education, your transcripts will be required as part of your application. **Specialized Experience required:** To qualify based on your work experience, your resume must describe at least one year of experience which prepared you to do the work of a Civil Engineer (Structural).

**For GS-11:** To qualify at the GS-11 grade level you must have at least one year of specialized experience equivalent to the GS-09 in federal service which includes: Experience (under the direct supervision of a senior engineer) in developing designs for structural features of navigation and flood control projects; preparing design engineering documents such as drawings, calculations and narratives; performing site evaluations and investigations; and developing design computations for structures made of steel, reinforced concrete, and other structural features such as miter gates, bridges, flood walls, and bulkheads.

**For GS-12:** To qualify at the GS-12 grade level you must have at least one year of specialized experience equivalent to the GS-11 level in the federal service which includes: Experience in independently developing designs for structural features of navigation and flood control projects; preparing design engineering documents such as drawings, calculations and narratives;

performing site evaluations and investigations; and developing design computations for structures made of steel, reinforced concrete, and other complex structural features such as miter gates, bridges, flood walls, and bulkheads. Experience in leading multidiscipline project design teams in the development of plans, specifications, and studies.

You will be evaluated on the basis of your level of competency (knowledge, skills, abilities) in the following areas:

- Knowledge of advanced structural engineering design techniques.
- Ability to make visual and structural assessments of structural systems and components.
- Skilled in analyzing data within structural engineering discipline.
- Knowledge of structural engineering codes, standards, and regulations.
- Ability to provide oral & written structural assessments.

**Education required:** This position has a minimum education requirement. In order to qualify for this position, you must meet one of the education requirements below in addition to the specialized experience statements described above.

- A bachelor's degree or above in professional engineering from a college or university accredited by the Accreditation Board for Engineering and Technology (ABET). NOTE: THIS DOES NOT INCLUDE ENGINEERING TECHNOLOGY;
- A bachelor's degree or above in professional engineering. The curriculum included differential and integral calculus and courses (more advanced than first- year physics and chemistry) in five of the following seven areas of engineering science or physics: (a) statistics, dynamics; (b) strength of materials (stress/strain relationships); (c) fluid mechanics, hydraulics; (d) thermodynamics; (e) electrical fields and circuits +ADs (f) nature and properties of materials (relating particle and aggregate structure to properties); and (g) any other comparable area of fundamental engineering science of physics, such as optics, heat transfer, soil mechanics, or electronics;
- Current registration as a professional engineer by a state in the United States, the District of Columbia, Guam, or Puerto Rico, in addition to college-level education, training, and/or technical expertise that furnished (1) a thorough knowledge of the physical and mathematical sciences underlying professional engineering, and (2) a good understanding, both theoretical and practical, of the engineering sciences and techniques and their applications to one of the branches of engineering;
- Successful completion of the Engineer in Training examination, or the written test required for professional registration, administered by the Boards of Engineering Examiners in the various States, the District of Columbia, Guam, and Puerto Rico in addition to completion of all the requirements for either (a) a bachelor's degree in engineering technology (BET) from an accredited college or university that included 60 semester hours of courses in the physical, mathematical, and engineering sciences, or (b) a BET from a program accredited by the ABET+ADs;
- A combination of at least 4 years of college-level education, training, and/or technical expertise that included successful completion of at least 60 semester hours of courses in the physical, mathematical, and engineering sciences, including the courses listed in paragraph B above. The courses are fully acceptable toward meeting the requirements of a professional engineering

curriculum; OR

- A bachelor's degree or higher-level degree in engineering technology or in an appropriate professional field (for example, physics, chemistry, architecture, computer science, mathematics, hydrology, or geology) and at least one (1) full year of professional engineering experience that was acquired under a professional training program or under professional engineering supervision and guidance.

Only degrees from an accredited college or university recognized by the Department of Education are acceptable to meet positive education requirements or to substitute education for experience. ## **REQUIRED DOCUMENTS:**
