C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Reference is made to your request for review of a delineation submitted for the Bryan Mckees Rocks Road site, dated October 25, 2007. This delineation was performed on the 32 acre property with unnamed tributaries to Chartiers River in Allegheny County, Pittsburgh, Pennsylvania. Regulatory Specialist William Wright conducted the desk review.

The Corps of Engineers' authority to regulate waters of the United States is based on the definitions and limits of jurisdiction contained in 33 CFR 328. Navigable waters, their tributaries, and surrounding wetlands are waters of the United States subject to the provisions of Section 404 of the Clean Water Act. Based on the information submitted and our review of the site, it has been determined that two jurisdictional tributaries (Tributary 1 and Tributary 2) totaling 1756 linear feet and two jurisdictional wetlands (Wetland A and B) which total 0.03 acres are present within the review area. These tributaries and wetlands have a hydrological connection to the Chartiers River, a Section 10 Navigable Waterway. Therefore, these tributaries and wetlands are part of a surface tributary system and are jurisdictional waters of the United States.

This delineation verification will remain valid for a period of five years from the date of this letter, unless new information warrants revision of the delineation. Every effort should be made to avoid impacts to aquatic resources on-site. If tributary or wetland impacts are proposed, this office should be contacted to discuss permit requirements.
