2. Non-regulated waters/wetlands (check if applicable):³

- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Two isolated nonRPWs, totalling 753' (41389-R2 (432') and 41389-R3 (321')), flow directly into cave portals. A field verification determined that flow is not connected to any other WOUS by any conveyance feature before the caves receive the streams. Both channels have formed as a result of being the topographical collection point of sheet flow. Both channels were dry at the time of the field verification and did not appear to experience a high volume of flow. There was leaf litter and live vegetation in the channels.**

Topography acted as the main constraint to flow staying within the channel and not connecting to any other conveyance feature (rills, gullies, swales, etc) or WOUS. An out of service mine road had a berm that acted as a physical barrier approximately one hundred feet to the south of both channels. The channels would have to experience significant flow (presumptively more than a 100 year event) in order to reach the berm. Elevation increased to the north of the channels. Naturally, the channels both moved downhill into the cave portals. Once the channels entered the cave portals, an investigation was done of the surrounding area for approximately a quarter mile radius. The channels, or any other flow, did not re-emerge except one place. Approximately 338' to the south of 41389-R2, and >1000' to the south of 41389-R3, 41389-R4 emerges from a spring. 41389-R4 is a perennial stream. The spring was visibly flowing during the field verification. Neither of the streams in question (41389-R2, R3) were flowing that day. Furthermore, the spring was not situated in a topographically logical position to assume that its source was 41389-R2 or R3.

Channel 41389-R6 (312') is an RPW channel that is situated in between a mining high wall and an out of service mining road. The channel is incised and showed no sign of floodplain connectivity. If the channel were to experience an extremely large event, and come out of its banks, it would not connect to any other WOUS. It would have to traverse approximately 200 feet of a relatively flat field in order to connect with the next WOUS (RPW). There were no visible swales or other feature in the field. This channel receives three other nonRPW channels (41389-R6B (96'), R6A (95'), R5 (116')) that appeared to be seeps from the high wall. None of these features clearly connected to any other WOUS, by jurisdictional or non-jurisdictional feature. On the north side, these features were isolated from any other feature by the high wall. Once the three channels either ended or connected to 41389-R6, 41389-R6 flows into a cave and does not reemerge anywhere within a reasonable proximity. The cave portal that 41389-R6 enters is the lowest point within the study area.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
