C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The forested wetlands and ephemeral stream channel convey flow indirectly to the nearest TNW, the Allegheny River, and provide a variety of functions that contribute to the quality of water entering that system. The adjacent PFO wetlands retain and filter water that would otherwise flow as runoff directly to the non-RPW stream. The size of the abutting PEM/PFO wetland allows for significant water storage, which decreases erosion, flooding, and flashiness of downstream waters. In addition, the wetland filters runoff from the adjacent land, which is primarily agricultural land use and may contain high concentrations of nutrients and pollutants. This filtration decreases nutrients and sediment in downstream waters. The wetland itself provides habitat for a variety of plant and animal life, which helps to sustain the larger ecosystem. Additionally, the wetland and non-RPW contribute to the process of nutrient cycling, and provide allochthonous material to downstream waters. Ephemeral headwater systems such as this can alter the water quality of receiving streams. Based on the collective functions described above and their importance to the biological, chemical, and physical integrity of the traditional navigable waters of the Allegheny River, this office has determined that there is a Significant Nexus between the review area Relevant Reach, its adjacent wetlands, and the downstream TNW.

It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The adjacent PEM wetlands retain and filter water that would otherwise flow as runoff directly to Stream S-3. This assists in decreasing erosion, flooding, and flashiness of downstream waters. In addition, the wetland filters runoff from the adjacent land, which is primarily agricultural land use and may contain high concentrations of nutrients and pollutants. This filtration decreases nutrients and sediment in downstream waters. The wetland itself provides habitat for a variety of plant and animal life, which helps to sustain the larger ecosystem. Based on the collective functions described above and their importance to the biological, chemical, and physical integrity of the traditional navigable waters of the Allegheny River, this office has determined that there is a Significant Nexus between the review area Relevant Reach, its adjacent wetlands, and the downstream TNW.

It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

In addition, the wetland filters runoff from the adjacent land, which is primarily agricultural land use and may contain high concentrations of nutrients and pollutants. This filtration decreases nutrients and sediment in downstream waters. The wetland itself provides habitat for a variety of plant and animal life, which helps to sustain the larger ecosystem. Based on the collective functions described above and their importance to the biological, chemical, and physical integrity of the traditional navigable waters of the Allegheny River, this office has determined that there is a Significant Nexus between the review area Relevant Reach, its adjacent wetlands, and the downstream TNW.

photographs, United States Geographical Society (USGS), Natural Resource Conservation Service (NRCS) soil survey, National Wetland Inventory (NWI) maps, topography data, and the materials submitted, the wetlands are determined to be hydrologically isolated with no surface water connection to a water of the United States (WOTUS). A review of the surrounding topography indicates the wetlands are within an isolated depression with no topographic connection to any other waterbody. The wetlands in review are surrounded by upland, and have no swales, ditches, pipes, or other means that would provide a surface or subsurface connection to a WOTUS. We have determined that these wetlands are isolated depressions and hydrologically separated from other aquatic resources. These wetlands do not have an ecological connection to a WOTUS.

There is no known information showing that Wetlands W-4, W-6, W-7, or W-11 supports a link to interstate or foreign commerce. There is no known information to suggest that Wetland Wetlands W-4, W-6, W-7, or W-11 is or may be used interstate or foreign travelers for recreation or other purposes; produces fish or shellfish that could be taken and sold in interstate or foreign commerce, or used for industrial purposes by industries in interstate or foreign commerce. A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. If the JD covers a tributary with adjacent wetlands, complete Section III.B.1 for the tributary, Section III.B.2 for any onsite wetlands, and Section III.B.3 for all wetlands adjacent to that tributary, both onsite and offsite. The determination whether a significant nexus exists is determined in Section III.C below.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?
- Does the tributary, in combination with its adjacent wetlands (if any), provide habitat and lifecycle support functions for fish and other species, such as feeding, nesting, spawning, or rearing young for species that are present in the TNW?

- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?
