Explain: **The review area for this jurisdictional determination is the extent of Wetland 11, a PEM wetland. There is no evidence of a surface or shallow subsurface hydrologic connection to any navigable waters or their tributaries. Based upon a review of aerial photographs, United States Geographical Society (USGS) 1:24K Quad and its associated National Hydrography Dataset (NHD), Natural Resource Conservation Service (NRCS) soil survey, National Wetland**

Inventory (NWI) maps, topography data, and the materials submitted, the wetland is determined to be hydrologically isolated with no surface water connection to a water of the United States (WOTUS). The closest jurisdictional feature, Little Raccoon Run, is approximately 465 feet away from Wetland 11. An upland berm surrounds the wetland and there was no observed flow between the adjacent aquatic resources. The desktop visit review of the surrounding topography indicates the wetland is within an isolated depression with no topographic connection to any other waterbody. The review area is not within a 100-year floodplain. The wetland in review is surrounded by non-jurisdictional upland, and have no swales, ditches, pipes, or other means that would provide a surface or subsurface connection to a WOTUS. We have determined that the wetland is an isolated depression and hydrologically separated from other aquatic resources. These wetland does not have an ecological connection to a WOTUS.

The wetland does not support a link to interstate or foreign commerce because it is not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate or foreign commerce. The wetland was determined to not be a WOTUS and not to be jurisdictional under the CWA.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetland 12 is a 0.13 acre depressional, palustrine emergent wetland within the review area. Wetland 12 is located on the eastern part of the AOI in a concave depression. The subject wetland is dominated by a monotypic stand of common reeds (common reed marsh). The subject small and shallow wetland appears to be an isolated body that has developed incidentally as a result of historic construction activity on or adjacent to these areas. It appears to have no obvious link to riparian areas (streams), groundwater seeps, complex wetland systems, floodplains, or larger bodies of water (ponds, lakes, coastal areas, etc.) but rather occurs as a consequence of historic disturbance / surface operations or construction activity on terrestrial land. This wetland drains to the nearest stormwater pond. Onsite activity has resulted in shallow sloping surrounding features with a few superficial depressional surface areas that typically retain a minimal amount of concentrated surface runoff (as would be the case with tire-ruts, etc.). Wetland hydrology flows via a small swale to a stormwater drainage ditch, approximately 100 feet from Wetland 14. The drainage ditch then flows into a manmade storm water detention pond. The pond is approximately 300 feet from Wetland 14. Based on historical aerials, the pond was excavated from uplands around the early 1980s. Flow from the stormwater pond is assumed to drain into Little Raccoon Run. The pond has visible inlet structures, though the outlet was not confirmed by aerial photos nor consultants in the field.

The subject wetland appears to be seasonally disturbed (mowed) as part of grounds maintenance and security. The surrounding areas are dominated by pasture/ turfgrasses and few narrow scrub / shrub areas. Its functional value is limited in terms of floodwater control, valued habitat (refuge) / food chain production, water purification, positive flushing characteristics, natural recharge areas, sediment control, salinity distribution, solute transport, or recreational value (fishing hiking, observations, etc.). Wetland 12 does not contain remarkable habitat, wildlife, or special significance which would attract interstate or foreign travel, nor does it contain resources which could be taken or sold in interstate or foreign commerce. Wetland 12 lacks a substantial hydrologic connection to a downstream receiving water and would not significantly affect the chemical, physical, and biological integrity of the TNW, located over 30 miles away.

Explain: **The review area for this jurisdictional determination is the extent of Wetland 13 and Wetland 14, two PEM wetlands. There is no evidence of a surface or shallow subsurface hydrologic connection to any navigable waters or their tributaries. Based upon a review of aerial photographs, United States Geographical Society (USGS) 1:24K Quad and its associated National Hydrography Dataset (NHD), Natural Resource Conservation Service (NRCS) soil survey,**

National Wetland Inventory (NWI) maps, topography data, and the materials submitted, the wetlands are determined to be hydrologically isolated with no surface water connection to a water of the United States (WOTUS). The closest jurisdictional feature, Little Raccoon Run, is approximately 390 feet away from Wetland 13. An upland berm surrounds the wetlands and there was no observed flow between the adjacent aquatic resources. The desktop review of the surrounding topography indicates the wetlands are within an isolated depression with no topographic connection to any other waterbody. The review area is not within a 100-year floodplain. The wetlands in review are surrounded by non-jurisdictional upland, and have no swales, ditches, pipes, or other means that would provide a surface or subsurface connection to a WOTUS. We have determined that the wetland is an isolated depression and hydrologically separated from other aquatic resources. These wetlands do not have an ecological connection to a WOTUS.

The wetlands do not support a link to interstate or foreign commerce because it is not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate or foreign commerce. The wetlands were determined to not be a WOTUS and not to be jurisdictional under the CWA.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW).
