This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Summarize overall biological, chemical and physical functions being performed: These small wetland areas pool water in wet conditions, and provide water retention and filtration functions as well as valuable habitat for vernal pool species such as amphibian larvae.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

Based on these functions and their importance to the biological, chemical, and physical integrity of the traditional navigable waters of the Mahoning River, this office has determined that there is a Significant Nexus between the review area Relevant Reach, its adjacent wetlands, and the downstream TNW.

B. ADDITIONAL COMMENTS TO SUPPORT JD: No streams are onsite. Wetland A drains into the offsite RPW upstream of the pond. Wetland C drains into Wetland B, which extends offsite and drains into the same RPW downstream of the pond. On the day of the AJD site visit, Wetland B had been impacted by construction vehicles and timber mats. Therefore, the boundaries and hydrologic connection were assumed based on prior conditions as recorded in the original wetland delineation.
