**Quad and its associated National Hydrography Dataset (NHD), Natural Resource Conservation Service (NRCS) soil survey, National Wetland Inventory (NWI) maps, topography data, and the materials submitted, the wetlands and stream are determined to be hydrologically isolated with no surface water connection to a water of the United States (WOTUS). A review of the surrounding topography indicates the wetlands do not have topographic connection to any other waterbody. This was confirmed with the 14 April 2022 site visit. The aquatic resources in review are surrounded by upland, and have no swales, ditches, pipes, or other means that would provide a surface or subsurface connection to a WOTUS. We have determined these features are isolated PEM wetlands that are hydrologically separated from other aquatic resources. These wetlands and stream do not have an ecological connection to a WOTUS. There is no known information showing that Wetland A, Wetland AA, and Stream B support a link to interstate or foreign commerce. There is no known information to suggest that the aquatic resources are or may be used by interstate or foreign travelers for recreation or other purposes; produce fish or shellfish that could be taken and sold in interstate or foreign commerce, or used for industrial purposes by industries in interstate or foreign commerce. Wetland A, Wetland AA, and Stream B were determined to not be a WOTUS and not to be jurisdictional under the CWA.**

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The Corps conducted a site visit with the consultant (ECS Mid-Atlantic, LLC) in April 2022 to inspect portions of the site and to conduct an inspection/verification of findings regarding the ECS Delineation Report. The Corps has followed the JD guidance as enumerated within the "U.S. Army Corps of Engineers Jurisdictional Determination Form Instructional Guidebook" dated 5/30/2007 and other applicable guidance. Wetland A is an isolated PEM wetland and ponded area



surrounded by uplands. Flow from Wetland AA is hydrologically connected to Wetland A via a small swale, thus they are included within the same reach. Flow from these wetlands continues through Stream B and offsite. The Corps followed flow offsite via public roads and found that the Stream B loses bed, banks, and hydrology and is therefore isolated from downstream TNWs. The surrounding area is heavily disturbed due to commercial and residential development.

its associated National Hydrography Dataset (NHD), Natural Resource Conservation Service (NRCS) soil survey, National Wetland Inventory (NWI) maps, topography data, and the materials submitted, the wetlands and stream are determined to be hydrologically isolated with no surface water connection to a water of the United States (WOTUS). A review of the surrounding topography indicates the wetlands do not have topographic connection to any other waterbody. This was confirmed with the 14 April 2022 site visit. The aquatic resources in review are surrounded by upland, and have no swales, ditches, pipes, or other means that would provide a surface or subsurface connection to a WOTUS. We have determined these features are isolated PEM wetlands that are hydrologically separated from other aquatic resources. These wetlands do not have an ecological connection to a WOTUS. There is no known information showing that Wetland AC, AE, and AD support a link to interstate or foreign commerce. There is no known information to suggest that the aquatic resources are or may be used by interstate or foreign travelers for recreation or other purposes; produce fish or shellfish that could be taken and sold in interstate or foreign commerce, or used for industrial purposes by industries in interstate or foreign commerce. Wetland AC, AE, and AD were determined to not be a WOTUS and not to be jurisdictional under the CWA.

National Hydrography Dataset (NHD), Natural Resource Conservation Service (NRCS) soil survey, National Wetland Inventory (NWI) maps, topography data, and the materials submitted, the wetland is determined to be hydrologically isolated with no surface water connection to a water of the United States (WOTUS). A review of the surrounding topography indicates the wetland does not have topographic connection to any other waterbody. This was confirmed with the 14 April 2022 site visit. National Hydrography Dataset (NHD), Natural Resource Conservation Service (NRCS) soil survey, National Wetland Inventory (NWI) maps, topography data, and the materials submitted, the wetland is determined to be hydrologically isolated with no surface water connection to a water of the United States (WOTUS). A review of the surrounding topography indicates the wetland does not have topographic connection to any other waterbody. This was confirmed with the 14 April 2022 site visit. The aquatic resources in review are surrounded by upland, and have no swales, ditches, pipes, or other means that would provide a surface or subsurface connection to a WOTUS. We have determined that this feature is an isolated PEM wetland that are hydrologically separated from other aquatic resources. The wetland does not have an ecological connection to a WOTUS. There is no known information showing that Wetland C supports a link to interstate or foreign commerce. There is no known information to suggest that the aquatic resources are or may be used by interstate or foreign travelers for recreation or other purposes; produce fish or shellfish that could be taken and sold in interstate or foreign commerce, or used for industrial purposes by industries in interstate or foreign commerce. Wetland C was determined to not be a WOTUS and not to be jurisdictional under the CWA.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
