B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. review area. Sawmill Creek flows generally north-northwest into Meander Creek, which is impounded immediately downstream of this confluence. Meander Creek Reservoir outlets as Meander Creek, which flows generally north into the Mahoning River, a TNW.

Other information on duration and volume: Stream 1 is a typical headwater stream that drains a relatively small upland areas via overland sheetflow. Although it had rained prior to the site visit, it was apparent that groundwater interaction occurs at least seasonally due to seasonal fluctuations in the depth of the water table. Additionally, the presence of substrate sorting in this reach demonstrates consistent flow. Thus, this stream contributes a base flow at least three months of the year, which is then augmented by precipitation events.

Explain: The review area is a vacant lot, previously harvested for timber, situated between developed residential areas and transportation infrastructure, namely N Broad St to the west and Interstate 76 to the north and east. Typical pollutants in areas such as these include pesticide and fertilizer runoff from residential lawns, and benzene and toluene from roadways. Stream 1 exhibited generally clear water, with no obvious sediments or contaminants. Overall water quality appears good, and the Ohio EPA lists this watershed as Eligible for their 2017 general Section 401 Water Quality Certification.

Identify specific pollutants, if known: No chemical testing was performed; therefore, specific pollutants were not identified.

The Ohio Rapid Assessment Method resulted in Wetland A scoring in Category 2, and all other wetlands scoring in Category 1. The wetlands on-site do not exhibit features of bogs, fens, or other high-value resources.

Summarize overall biological, chemical and physical functions being performed: Wetlands A and B are performing typical wetland functions including sediment and pollutant filtering, floodwater retention, and providing habitat for aquatic and terrestrial organisms. These wetlands exhibit an overall degraded quality as evidenced by the low ORAM scores, which are limited due to the position of the site within the watershed and the relatively small drainage area, and further constrained by the amount of development in the surrounding area.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Explain: The review area is a vacant lot, previously harvested for timber, situated between developed residential areas and transportation infrastructure, namely N Broad St to the west and Interstate 76 to the north and east. Typical pollutants in areas such as these include pesticide and fertilizer runoff from residential lawns, and benzene and toluene from roadways. Stream 2 exhibited generally clear water, with no obvious sediments or contaminants. Overall water quality appears good, and the Ohio EPA lists this watershed as Eligible for their 2017 general Section 401 Water Quality Certification.

Summarize overall biological, chemical and physical functions being performed: Wetlands A, B, D, E, G, I, and J are performing typical wetland functions including sediment and pollutant filtering, floodwater retention, and providing habitat for aquatic and terrestrial organisms. These wetlands exhibit an overall degraded quality as evidenced by the low ORAM scores, which are limited due to the position of the site within the watershed and the relatively small drainage area, and further constrained by the amount of development in the surrounding area.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW.
