Reference is made to your request for review of a delineation, received on October 6, 2016. A delineation of the proposed Harrison Hills CSD new K-12 school in Cadiz, Harrison County, Ohio (40.263305/-80.995159) was performed during the summer/fall of 2016 by CTL Engineering, Inc.

The Corps of Engineers' authority to regulate waters of the United States is based on the definitions and limits of jurisdiction contained in 33 CFR 328. Navigable waters, their tributaries, and surrounding wetlands are waters of the United States subject to the provisions of Section 404 of the Clean Water Act. Based on the information submitted it has been determined that wetlands 2a, 2b, 2c, 2d, 5, 6, 7a, 7b, and 8, as delineated by CTL Engineering Inc. for the Harrison Hills CSD new K-12 school, are all isolated and non-jurisdictional. The non-jurisdictional wetlands total 1.74 acre. The isolated wetlands were coordinated with the U.S. Environmental Protection Agency and Corps Headquarters, as required, and did not receive comment. Therefore this jurisdictional determination is final. Please note, that the Ohio Environmental Protection Agency (OEPA) regulates isolated wetlands and their office should be contacted before beginning any work on Harrison Hills CSD new K-12 school site.

This delineation verification will remain valid for a period of five years from the date of this letter, unless new information warrants revision of the delineation. Every effort should be made to avoid impacts to the aquatic resources on-site. If stream or wetland impacts are proposed to jurisdictional resources, this office should be contacted to discuss permit requirements.

Your signature on the Standard Permit or acceptance of the LOP means that you accept the permit in its entirety, and waive all rights to appeal the permit, including its terms and conditions, and approved jurisdictional determinations associated with the permit.
- **OBJECT:** If you object to the permit (Standard or LOP) because of certain terms and conditions therein, you may request that the permit be modified accordingly. You must complete Section II of this form and return the form to the district engineer. Your objections must be received by the district engineer within 60 days of the date of this notice, or you will forfeit your right to appeal the permit in the future. Upon receipt of your letter, the district engineer will evaluate your objections and may: (a) modify the permit to address all of your concerns, (b) modify the permit to address some of your objections, or (c) not modify the permit having determined that the permit should be issued as previously written. After evaluating your objections, the district engineer will send you a proffered permit for your reconsideration, as indicated in Section B below.

B: PROFFERED PERMIT: You may accept or appeal the permit.

If you received a Letter of Permission (LOP), you may accept the LOP and your work is authorized. - **APPEAL:** If you choose to decline the proffered permit (Standard or LOP) because of certain terms and conditions therein, you may appeal the declined permit under the Corps of Engineers Administrative Appeal Process by completing Section II of this form and sending the form to the division engineer. This form must be received by the division engineer within 60 days of the date of this notice.

C: PERMIT DENIAL: You may appeal the denial of a permit under the Corps of Engineers Administrative Appeal Process by completing Section II of this form and sending the form to the division engineer. This form must be received by the division engineer within 60 days of the date of this notice.

D: APPROVED JURISDICTIONAL DETERMINATION: You may accept or appeal the approved JD or provide new information.

- **ACCEPT:** You do not need to notify the Corps to accept an approved JD. Failure to notify the Corps within 60 days of the date of this notice, means that you accept the approved JD in its entirety, and waive all rights to appeal the approved JD.

This form must be received by the division engineer within 60 days of the date of this notice.

- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **5 wetlands that met the criteria and definition of a wetland (wetlands 2, 5, 6, 7, and 8) were all in the project area but were all isolated. Upon field investigation, it was determined that there was no surface connection to any other feature, jurisdictional or not. All of these wetlands were truly depressional features that had formed as a result of rain water collection. All systems are emergent and are at least 0.2 miles from the nearest jurisdictional waterway (Mill Run) and as some as far as 0.6 miles. A thorough field investigation was done in all of the areas surrounding the**

wetlands and no swales, ditches, rills, or any other feature was found to convey the flow outside of the wetland boundary. A tire rut could have possibly conveyed some flow from wetland 2 to the east. But there was no evidence of regular flow and the tire rut only extended several feet beyond the wetland boundary.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
