C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Site visit noted from 10-AUG-2017. Background: The site is large sloped area that was clear cut approximately 15 months ago and is situated below a ridge line with several wind mills. At the toe of the slope several mine discharges seep out of the ground. The upslope area was previously contour strip mined and reclaimed. Rainfall: approximately 2.0 inches of rain fell in the 6 days prior to the site visit. During the visit it was notably wet across the landscape of the site. Inspected site with group

after meeting to discuss DEP comments on project. Generally speaking the water quality is of low pH (range 3.63 to 6.8 – varies by channel), high conductance (range 100 to 3,500), and high sulfates (29 to 3,400). It is apparent that the hydrology on site is mine discharge and lacks the ability to support aquatic life, at least on-site and immediately off-site. The discharges drain to an unnamed tributary to Boone Run (1.76 miles), to Lake Stoneycreek (4.20 miles), to Rhoads Creek (4.34 miles), to Stonycreek River (5.20 miles).
