Discrete wetland hydrologic connection. Explain: During the site visit on April 5, 2018, the surrounding area had recently experienced rain and melting snow. (It was very wet.) As a result the water could be seen discharging from Wetland A via a discrete confined connection however this connection did not have an OHWM. Water was flowing north and entering a culvert and being discharged into a pond.

Summarize overall biological, chemical and physical functions being performed: Wetland A provides retention of flood waters from immediately entering downstream WOUS. It provides surface runoff filtering capabilities from the surrounding urban development. It is a good quality PEM, PSS, PFO wetland which undoubtedly provides habitat for wildlife in the surrounding area.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Therefore wetland A has more than a speculative or insubstantial effect on the chemical, biological, or physical integrity of the TNW and is jurisdictional.

**Wetland A by uplands. No ecological connections were noted that were more than speculative. There is no chance for shallow surface flow and the wetlands are not located in a floodplain. Further there is not a RPW (or nRPW for that matter) on the site to convey waters to Waters of the U.S. The site was re-visited on April 5, 2018, to follow up on a comment from USEPA Region V. They provided the Stream Stats map that showed a connection from Wetland A in the northwest corner flowing north to the offsite pond. Upon the field view it was realized water was flowing from Wetland A in a northerly direction into the pond via a confined swale, that did not contain an Ordinary High Water Mark (OHWM), and a culvert under Royal Troon Drive. Verification of this connection to the pond which discharges to WOUS resulted in this revised AJD form and Wetland A being considered jurisdictional (see other AJD form). All other wetlands onsite to the south are still considered isolated.**

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW.
