Rationale: Revised report did not include off-site analysis of Wetland A's adjacency to (a)(2) waters, site visit was needed and conducted by the Corps on April 9, 2021. Based upon aerial mapping and the April 9 site visit it was determined that Wetland A is adjacent to (a)(2) waters and therefore under the jurisdiction of the Corps.

be included for this project. The project area increased (from 5.6 acres to 7 acres) and the consultant prepared a revised Water Resource Delineation Report (March 2021). Based upon review of aerial mapping, the additional wetland area appeared to be one contiguous wetland complex adjacent to UNTs to Andersons Run. The revised wetland delineation report included an additional 0.6 acre of wetland area (Oct 2020 report 2.692 acres, March 2021 report 3.288 acres, including 2.351 acre PEM, 0.303 acre PFO, and 0.634 acre PSS). For these reasons a site visit was conducted on April 9, 2021. Wetland A was found to be one large wetland complex adjacent to UNTs to Andersons Run and therefore jurisdictional to the Corps.
