### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

Stream 1a has somewhat well defined bed and banks and an OHWM that would undoubtedly convey water to the downstream TNW that is approximately 12 miles away. Given the bed and banks, this tributary would have the capacity to transport pollutants and floodwaters to the downstream TNW as well. While some lifecycle support functions would be somewhat limited, due to the streams ephemeral classification, this tributary definitely transports carbon to downstream foodwebs when flowing. Additionally substrate would be transported during high flow as well as heavy rainwater. Therefore this nRPW does have more than a speculative or insubstantial effect on the chemical, biological, or physical integrity of the TNW. It is for this reason that jurisdiction can be taken on this non-RPW.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

This wetland does not contain an inlet or outlet and the only source of hydrology is run off from the parking lot. At the base of the shopping center embankment there is a rock buttress. These isolated wetlands do not have a nexus with interstate or foreign commerce and therefore cannot be regulated.**

ADDITIONAL COMMENTS TO SUPPORT JD:** Field view conducted on 10-1-14 by Matt Mason-Corps, Ed Wilk and Carol Seighley-Ohio EPA and delineations of Wetlands D, E, and F were determined to be accurate. Wetlands D and E are depressional wetlands that are located on reclaimed surface mined areas of the site and do not contain an inlet or outlet - see the attached photographs. Wetland F is located on the hillside adjacent to the shopping center on a very steep slope. This wetland does not contain an inlet or outlet. At the base of the shopping center embankment there is a rock buttress.
