Current List of Navigable Waters of the United States Within the Pittsburgh District

1. **TO ALL WHOM IT MAY CONCERN:** This Public Notice supersedes Public Notice No. 00-54 dated October 3, 2000. Changes from Public Notice No. 00-54 are indicated by an asterisk (*).
2. In the administration of the laws enacted by Congress, the Corps of Engineers exercises jurisdiction over the streams within the Pittsburgh District listed below which are designated as "Navigable Waters of the United States". Department of the Army permits are required, pursuant of Section 10 of the 1899 Rivers and Harbors Act and Section 404 of the Clean Water Act, for all work and structures (exclusive of bridges) in, adjacent to, or across these streams, below the elevation of Ordinary High Water, to the limits shown.³
3. It should be noted that the Potomac River has been added (*) to the list of navigable waters.

FOR WORK IN THE PITTSBURGH DISTRICT, WITHIN THE WATERWAYS LISTED BELOW, A SECTION 10 DEPARTMENT OF THE ARMY PERMIT IS REQUIRED.
